#### Hawaii's Sunshine Law (Open Meetings)

Lee-Ann Brewer from the State of Hawaii Office of Information Practices (OIP) delivered a comprehensive training on Hawaii's Open Meetings Law, as defined in Hawaii Revised Statutes (HRS) Chapter 92.

The presentation covered the core principles of the Sunshine Law, including the intent to protect the public's right to know, the legal definition of a "board," and requirements for public notice, agendas, board packets, public testimony, and minutes. Ms. Brewer detailed the specific procedures for conducting open meetings, executive sessions, and remote meetings. She also clarified the rules governing permitted interactions between board members outside of a formal meeting, including the use of Permitted Interaction Groups (PIGs).

Council members expressed their appreciation for the informative session. A discussion followed regarding the need to adjust future meeting agendas to ensure full compliance with best practices. A copy of the OIP's "Open Meetings Guide to the Sunshine Law" was provided as a resource.

# **Cheryl's Input on Reporting Importance**

- Emphasized guarterly/monthly reporting ensures everyone's work is captured and recognized
- Noted it prevents relying on "two or three of us trying to remember all the little things"
- Advocated for formalized documentation and verification process
- Stressed importance of giving every event proper recognition

# **Community Collaboration**

- Discussion about including other organizations: Project Dana, Catholic Charities, Dana Keala, Meals on Wheels, Parkinson's Association
- Quarterly meetings open to broader community participation
- Goal to expand independent living network impact

# Financial Report – Judy Guajardo

#### **Current Financial Status**

Beginning Balance: \$165,215.50

• Subtractions: \$12,412.68

• Current Balance: \$152,791.31

Gain: \$249 (tax refund)

# **Expense Breakdown**

- Operations costs including accounting and tax liabilities
- Gusto payroll taxes
- Travel expenses (~\$7,503 for National Council of Independent Living conference, budgeted up to \$8,000)

#### **Recent Developments**

- Received payment from DSSE for February-May: \$33,871.68
- New bookkeeper (Kim from Supporting Strategies) providing monthly reports
- Monthly income expected: ~\$8,467.92
- Contract execution delays resolved, back on track for timely invoicing

#### **Cheryl's Administrative Updates**

- Explained contract execution delays caused backup in invoicing
- Staff turnover at fiscal office caused processing delays
- Vendor address correction needed check went to Bishop Street instead of Queen Street Hub address
- Put in request to update both physical and mailing addresses in fiscal system
- Confirmed they're back on track for monthly payments

#### Investment Discussion



- Patrick proposes moving \$100,000-\$150,000 into Certificates of Deposit (CDs) rather than keeping in checking
- Jodi's recommendation: Use 6-8 month terms for flexibility, similar to Assistive Technology Resource Centers of Hawaii (ATRC) approach
- American Savings Bank requires "new money" for CDs, so need different bank
- Patrick suggests shopping around for rates, possibly Central Pacific Bank
- Topic tabled for next meeting with rate shopping

# Maui Report (Nani)

- Successful signwaving event with diverse participation
- Maui Deaf Friends, Maui Wheelers, Special Activities Committee (SAC), Developmental Disabilities
  (DD) clients participated
- Special cupcakes provided
- Post-event tsunami response highlighted accessibility issues
- Governor's television address lacked American Sign Language (ASL) interpreter initially
- Community advocacy led to interpreter being provided
- Planning for future events, not waiting 5 years for 40th anniversary

#### Statewide Summary (Patrick)

- 100 people participated on Oahu
- Events held on Maui, Big Island (Hilo, Kona), Molokai



- Excellent media coverage, government proclamations
- Budget: \$1,200 allocated, ~\$900 spent
- Planning group meeting monthly with Disability and Communication Access Board (DCAB)
- T-shirts finally arrived for 35th anniversary photos

#### **Donald's Contributions**

- Attended post-ADA planning meeting
- Reported on t-shirt availability for group photos
- Noted excellent news coverage and government support

# National Council of Independent Living Conference - Amanda Lowe

#### **Conference Overview**

- Dates: July 22-24, Washington District of Columbia (DC)
- Attendees: Amanda, Philip, Donald, Patrick
- Met ACL project officer Heyab in person
- Connected with other SILCs and CILs nationwide

#### Capitol March and Rally

- March from conference site to Capitol
- Speakers included consumers, Senator Bernie Sanders, Representative Simons (Maryland)
- Traffic was blocked during march
- Powerful advocacy demonstrations

#### Philip's Reflection on Advocacy Experience

- Noted how the group "actually blocked traffic" during the march to Capitol
- Described the energy of the rally with people calling out "cries and slogans"
- Emphasized seeing "people with disabilities out in force and actually making a statement"
- Observed that "Hawaii tends to be quiet" but stressed importance of advocacy
- Connected ADA work with lobbying against budget cuts to independent living programs, DD support, and university affiliated programs
- Mentioned following "the big House Resolution 1 (HR1) bill"
- Called the experience "something really nice to be a part of"

# **Congressional Meetings**



- Met with staffers from Senators Schatz and Hirono
- Met with Representative Case's staff (Case was on House floor)
- In-person meeting with Congresswoman Jill Tokuda
- Focus: Increased funding for independent living programs, opposing cuts to Protection Advocacy Agencies and University Centers for Excellence in Developmental Disabilities (UCEDDs)

# **Key Advocacy Points (Donald)**

- Airline accessibility for wheelchair users new aircraft by 2026-2028 should improve bathroom accessibility
- Hawaii handicap parking issues working with State Rep. Scott Matoshi on legislation for driver-side access
- Federal vs. state/local approach under Trump administration

# **Collaborative Opportunities**

- Offered SILC as resource to congressional offices for disability-related constituent issues
- Learned how to submit stories through Senator Schatz's website
- Encouraged to engage with representatives in other districts

# Post-ADA Events (Nani)

- Kupuna luncheon day after ADA signwaving on Maui
- Joe Tokuda attended, deaf community advocacy
- Two ASL interpreters provided (improvement from previous years)
- Maui Economic Opportunity (MEO) ensured proper accommodations
- Deaf community approached council members and apologized for not being able to join ADA signwaving but saw everyone the next day
- Deaf community advocated about importance of accommodations
- Number one challenge they always have at kupuna luncheon is sign language interpreter this year they had two
- Maui Island Minority Affairs (MIMA) presentation scheduled for deaf community meeting to get feedback about ADA accommodations
